Education - Ensure that all children are ready to start school and stay in school by funding internal and community partner operations to provide free or low-cost resources, including: programs that support childhood literacy by matching students with tutors and raising books for classrooms, home visitations to first-time parents, and college preparedness programs. Through these methods, we will help the 20% of third-graders who are not reading at grade level increase their reading proficiency and have a better chance of graduating high school on time. Third-grade reading scores in our community have improved from 70.8% in 2011 to 78.4% in 2014.

4b (Code:) (Expenses \$ **650,815** including grants of \$ **255,893**) (Revenue \$)

Income - Empower families and individuals to have rewarding and sustainable lives by funding internal and community partner operations to provide free or low-cost resources, including: free income tax preparation assistance, utilities and rent assistance, job skills training, adult computer literacy classes, support for homeless individuals, help finding affordable housing, and classes to help members of the community increase their financial knowledge and skills. In 2015, we brought back more than \$5 million in tax refund money to our community through the VITA program. With these efforts, we will increase the stability and earning potential of the patrons we serve.

4c (Code:) (Expenses \$ **1,088,737** including grants of \$ **151,557**) (Revenue \$)

Health - Encourage resiliency and support youth in our communities and neighborhoods by funding internal and community partner operations to provide free or low-cost resources, including: programs that promote health education and child abuse prevention, early detection of childhood developmental delays, healthcare provider information referrals, emotional support for kinship care providers, and programs that provide support for individuals with disabilities. Last year, our Help Me Grow program performed 3,907 screenings. Parents of 2,141 children were referred to a specialist (with follow-up support from our staff) for help with growth development, communication, behavioral, and gross motor skills that may have been missed otherwise. The program was begun in 2010.
